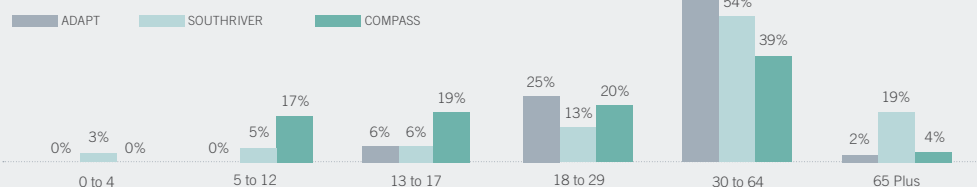
Medical and Behavioral Health Care

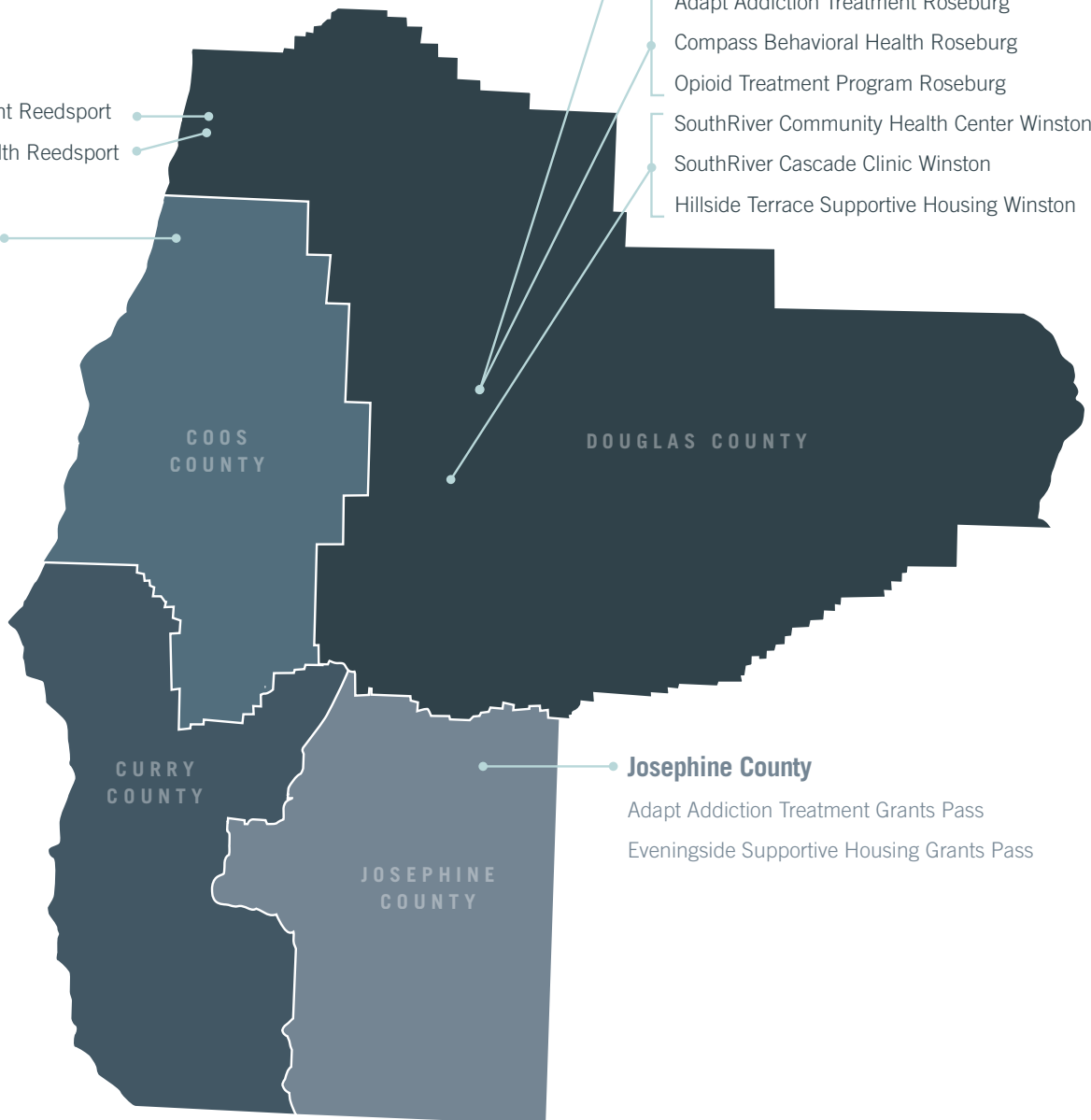

Our approach is to treat the whole person—identifying each individual’s unique strengths and needs and matching them with the most appropriate care.

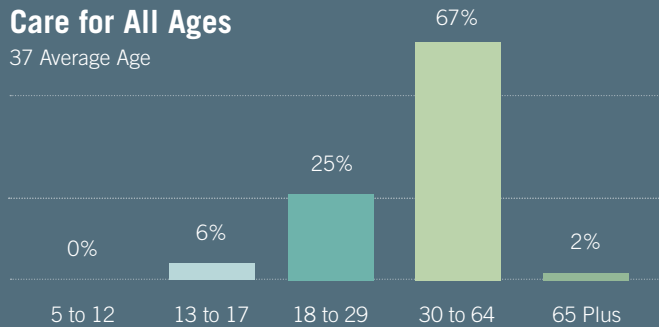
We offer a full-continuum of essential care for individuals and families with substance use and co-occurring behavioral health disorders—from medical detox and residential care to outpatient treatment and after care. Our programs connect science with practice to bring hope, health and recovery to the children, adolescents, adults and families we serve.

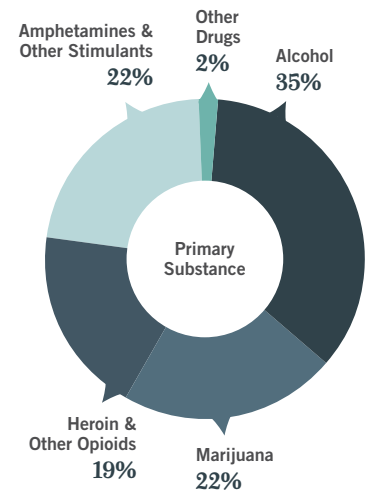
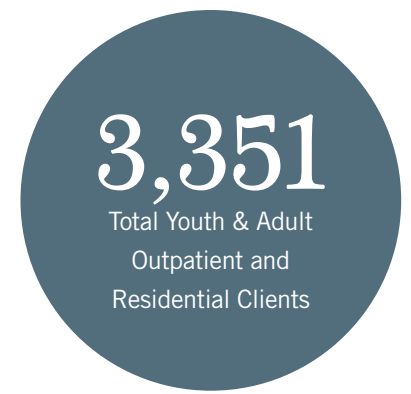

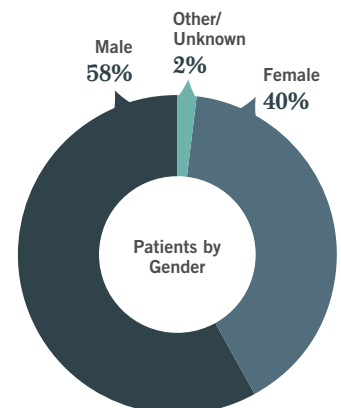
At The Crossroads

Everyone’s treatment needs are different, but the most important step to recovery is the first one. For those who require medical assistance to safely stop drinking or drug use, Adapt’s licensed sub-acute residential detoxification program at The Crossroads offers medically monitored or monitored acute treatment to help adults safely and effectively detoxify from alcohol, opiates and other drugs.

Because some patients enter residential care as the next step after detoxification, our 32-bed residential treatment center offers a safe, supportive and therapeutic treatment environment where adult men, women, and women with young children (ages 0-6) can restore their health and rebuild their lives. In 2018, 543 individuals received detoxification and/or residential treatment services to begin their journey to life-long health and recovery.

Breaking the Cycle

Corrections Treatment Services

Recovery is about having hope for the future. It's a life-long process of change to restore and sustain a productive life at home, at work and in the community.

Adapt works in cooperation with community corrections agencies to provide a full range of outpatient, residential care and after care services. Our skilled treatment counselors provide individualized, evidence-based treatment, focused not just on the skills needed to maintain long-term recovery, but also to reduce the risk of future criminal activity and incarceration. In 2018, we provided corrections treatment and support services to 633 corrections-involved individuals.

30 Years & Counting

Deer Creek Youth Residential Care

Being a teenager can be a time of wonder and a time of increased pressure that can lead some young people to abuse drugs—alcohol, tobacco, illegal and prescription drugs. For 30 years, Deer Creek Youth Residential Treatment Center has provided care for young people struggling with substance use and behavioral disorders that make it difficult to function well at home, school and in their community. Certified counselors provide evidence-based and age-appropriate treatment that focuses on whole-person health and recovery, including physical health, family counseling, therapeutic recreation, cultural development and personal skill-building. And, because treatment and education go hand-in-hand, Deer Creek is certified as a Phoenix School extension, young people are able to work toward their educational goals while receiving care. In 2018, Deer Creek helped 58 adolescents on their way to productive, healthy and rewarding lives.

Restoring Hope & Lives

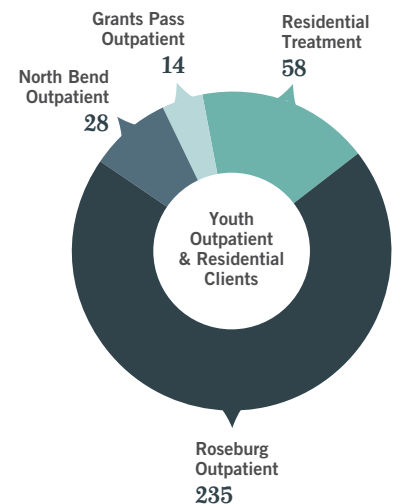
Adapt Opioid Treatment Program

Opioid use disorder is a chronic, life-threatening medical condition. Much like high blood pressure and diabetes, opioid use disorder requires long-term chronic disease management services provided by skilled professionals.

Medication-assisted treatment is the gold standard for treatment of opioid use disorder. Medication-assisted treatment combines prescribed medications—buprenorphine and methadone—with behavioral therapies to help people remain in treatment and achieve long-term recovery from alcohol, opioid and other drug dependence. Adapt opened its first Opioid Treatment Program in Roseburg in 2017, and in 2018 opened a second Opioid Treatment Program in North Bend. In 2018, a total of 424 individuals received life-saving medication-assisted treatment for opioid use disorder.

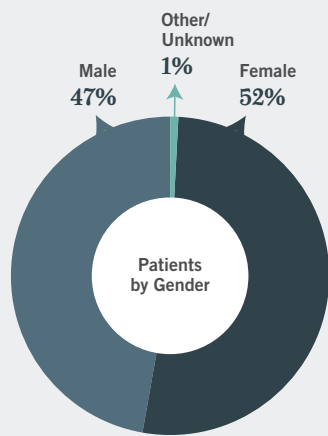

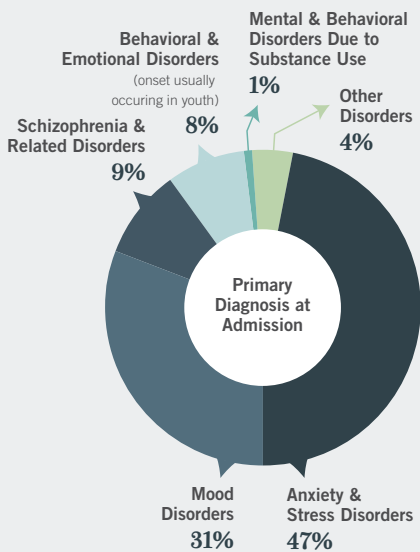
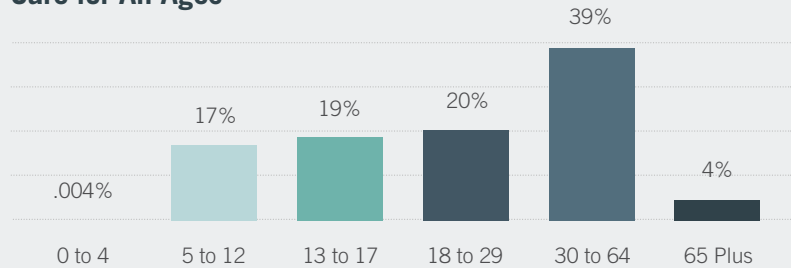
Building Healthy, Strong and Resilient People and Communities

As the Local Mental Health Authority and Community Mental Health Program for Douglas County, Adapt is responsible for providing a seamless system of care that meets the complex mental health needs of our community. We take that responsibility seriously. With careful attention to advancements in brain science and the clinical treatment of mental illness, we have set the course for expanded services and new partnerships to strengthen the delivery of recovery-oriented mental health care.

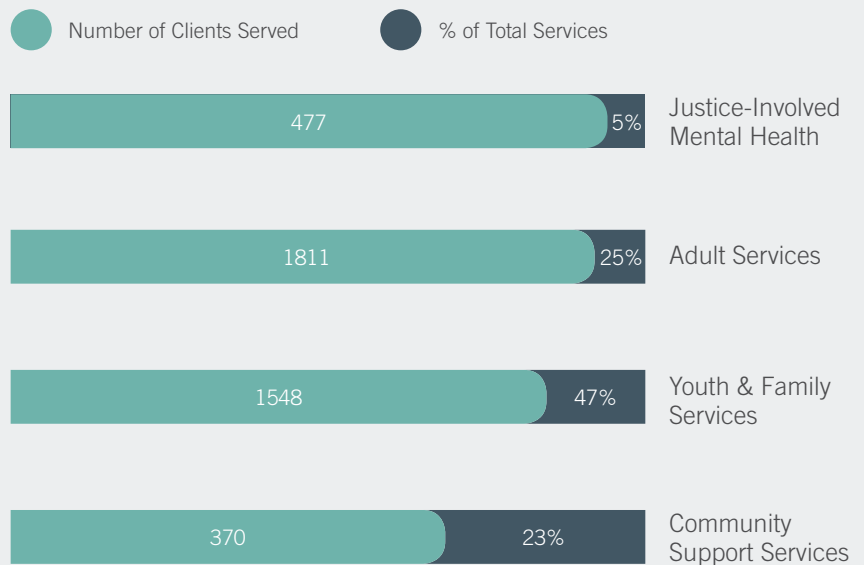
The transition of Douglas County's Community Mental Health Program to Adapt in 2016 created a unique opportunity to welcome and grow a skilled professional team of psychiatrists, psychiatric nurse practitioners, nurses, licensed and credentialed mental health professionals and administrative staff who are dedicated to helping our clients achieve stability and gain the skills and resources needed to be successful at home, work, school and in the community. Since that time, we have seen a 25% increase in our client volume—from 2,912 clients in 2016 to 3,638 clients in 2018.

Stabilizing Personal and Family Emergencies

Solutions to Reduce and Respond to Crisis

Compass Behavioral Health provides 24-hour crisis response that is consistent with principles of recovery and resilience and strives to reduce future crises by focusing on real solutions. Our skilled Crisis Team works with law enforcement, health systems, social service providers, and others to provide crisis intervention services to improve outcomes for people in crisis—and to reduce the burden on the emergency room and criminal justice system. We are proud to continue work with the Roseburg Police Department to connect people experiencing a mental health or substance use crisis with the most appropriate level of care. In 2018, 268 Compass clients received crisis intervention services, and another 2,024 phone calls to our 24-hour crisis line provided critical access to care.

Addressing Youth & Family Mental Health Needs

Quality Care at School and in the Community

Compass Youth & Family works closely with schools, health systems, social service agencies and other community partners to ensure that mental health treatment and community supports are available for youth and their families. Because our school-based services aim to treat and stabilize youth in the most accessible and least restrictive environment, Compass offers individual, group and family counseling year-round at school and in students' homes.

In 2018, skilled therapists provided care to 604 students in 31 schools and two school-based health centers, representing 12 Douglas County school districts. Working in cooperation with the Douglas Education Service District, we increased psychiatric day treatment services—also known as Therapeutic Learning Classroom—for students in kindergarten through 8th grade with emotional or behavioral difficulties that impact their ability to be successful in school, home and in the community. This evidence-based program is now available to all Douglas County students in kindergarten through 8th grade in three regional locations—Roseburg, Myrtle Creek and Sutherlin.

Fostering Success & Independence

Supporting Positive Outcomes

Compass Community Support Services is an important part of our comprehensive system of care—focusing on each individual's unique needs to successfully manage their symptoms, maintain stability and live independently in their own community. Our Community Support Services team consists of mental health and substance use treatment providers, nurses, peer specialists, employment specialists and other skilled professionals who work together to provide essential mental health services to address the often-complex needs of our clients. In 2018, 370 individuals received personalized support services to be successful in their treatment and lives.

SOUTHRIVER COMMUNITY HEALTH CENTER

Improving Health & Lives

Established in 2006, SouthRiver Community Health Center has grown to provide fully-integrated physical and behavioral health care services in two clinic locations in Winston. SouthRiver served 4,008 patients in 2018, an 8% increase over 2017.

Improving patient and population health requires a focus on health equity—equity of access, treatment, and outcomes. SouthRiver’s clinical team works with our patients and in the community to address the social factors that create obstacles to improved health. The following are just a few of the efforts underway to put good health within reach of more people.

Identifying and Treating Opioid Use Disorder

Medication-Assisted Treatment is reducing barriers to care for SouthRiver patients who struggle with opioid use disorder. Combined with individual and group counseling, SouthRiver medical providers are authorized to prescribe Suboxone to reduce the symptoms of opioid addiction and withdrawal. In 2018, 335 patients received medication-assisted treatment for opioid use disorder, an 84% increase over 2017.

Integrating Physical & Behavioral Health Care

People with serious mental illness experience significant gaps in health care, resulting in poor health, shorter life expectancies, and higher health care costs. SouthRiver is taking steps to address barriers to medical care for people with substance use and mental health disorders by co-locating primary care services at Adapt’s behavioral health facility in Roseburg. This effort will improve care for individuals at greatest risk of poor health outcomes, including those with trauma histories and/or severe and persistent mental illness.

Focus on Patients Experiencing Homelessness

Being homeless can contribute to poor health, and poor health can lead to homelessness. In 2018, 777 patients identified as homeless—19% of SouthRiver’s total patient count. To better identify and address the health needs of patients experiencing homelessness, SouthRiver implemented a robust electronic health record coding system to ensure a more thorough screening of patient housing status. Clinical staff are trained in patient-centered “asking practices” to avoid potential stigma around homelessness.

Improving Care for Justice System Involved Individuals

In partnership with the Local Public Safety Coordinating Council and the Department of Human Services, SouthRiver is helping inmates enroll in the Oregon Health Plan and connect with critical social services prior to release. In 2018, over 400 individuals received support to help meet their post-release health needs.

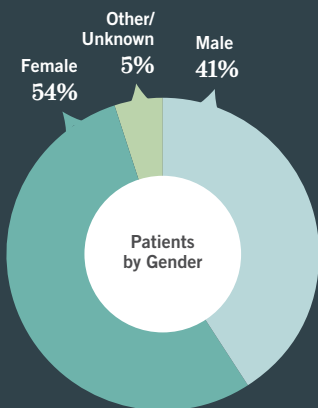
Quality of Care Measures

SouthRiver's dedicated staff provides patients with the services they need when they need them, including specialty care for patients with diabetes, chronic pain, substance use disorders and other complex health conditions. Our most impressive accomplishments are reflected in the gains made in meeting local, state and national quality of care measures. The SouthRiver clinical team reviews quality of care measures and creates performance improvement plans to streamline clinical workflow, enhance patient care, and improve health outcomes. In 2018, SouthRiver made measurable improvements on a number of quality of care measures.

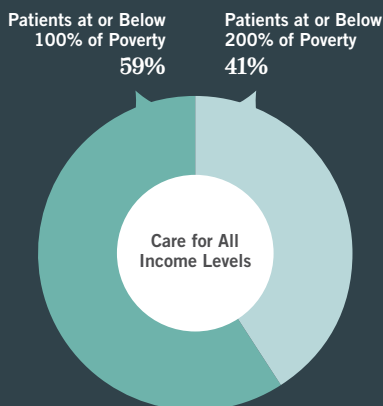
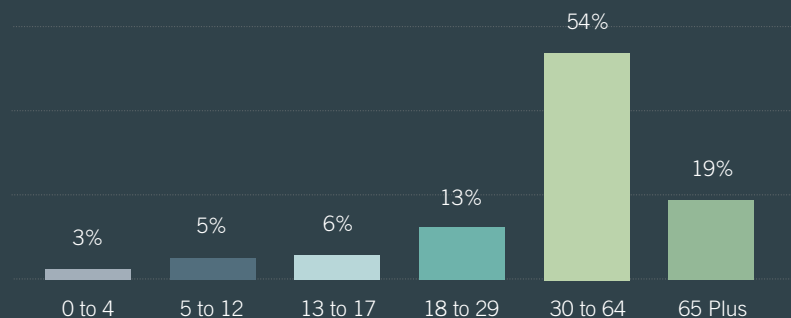

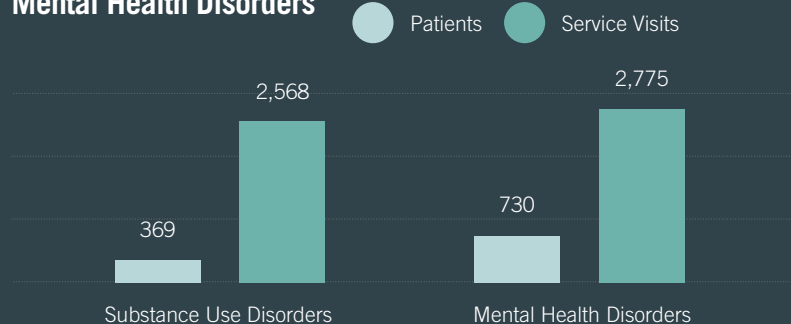

ENGAGING PEOPLE AND COMMUNITIES

Working Together with Community Partners to Improve Health

We know that good health and long-term recovery take place in communities. Throughout our organization, our employees are working hand-in-hand with community partners to promote healthy communities and to bring health within reach for more people. We're investing in innovative programs and partnerships to achieve our long-term strategic goals to improve access to care, expand service delivery and to create opportunities for good health for all.

Safe, Affordable and Supportive Housing is Sometimes the Best Medicine

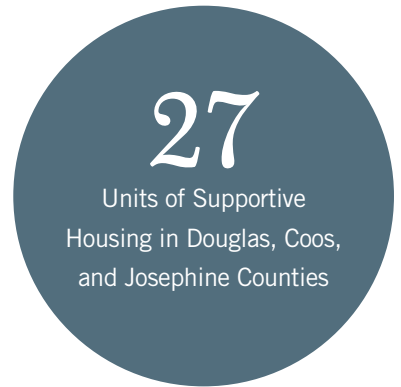
The lack of a safe, alcohol and drug-free living environment can be a barrier for individuals transitioning out of an addiction treatment program. Adapt now operates a total of 27 units of Supportive Housing for non-parenting adults and for adults with children in Douglas, Coos and Josephine counties. Each one of these units represents a significant investment of state and local partners.

Hillside Terrace in Winston and **Eveningside Apartments** in Grants Pass offer safe, supportive, temporary housing for child-welfare involved parents in recovery and their children. Adapt works in close cooperation with the Oregon Department of Human Services Child Welfare Program to arrange placements to ensure the necessary supports are in place to safely reunite children with their families. Working in partnership with Advanced Health, Adapt also operates **Fresh Start Day Treatment** in North Bend. Individuals enrolled in Fresh Start live in their own homes or in on-site supportive housing while receiving treatment. The goal of Fresh Start is to help clients become stable in their treatment and recovery as a necessary first step to a healthy, drug-free and productive life.

Recovery Through Work

Local Employers Bring Diversity to their Workforce

We believe that anyone who wants to work can work, including people with behavioral health conditions. Compass Behavioral Health IPS Supported Employment team helps our Douglas County clients identify and pursue their employment goals. In 2018, and in partnership with 25 employers from throughout Douglas County, IPS Supported Employment worked with 58 individuals to foster wellness, recovery and self-sufficiency through meaningful employment.

Prevention: A United Community Front

Educating, Empowering and Encouraging

The work being done by our Prevention & Education Program is grounded in the science of prevention and focuses on reducing the risk factors that lead to problem behaviors and increasing the protective factors that support the health and well-being of youth, adults, families and entire communities.

In 2018, we reached hundreds of youth and families through our community-based prevention efforts, such as The Blast 5k Run Walk and the Art of Prevention. The Blast engaged 266 people from throughout Oregon to run and walk for a cause, such as preventing substance abuse, suicide and bullying. The Annual Art of Prevention art contest and show empowered young people in grades 4 through 12 to create art focusing on preventing problem behaviors and increasing healthy behaviors. This year, 356 students representing 14 schools participated in event presentations, art contest and art show. We are proud to work in and with our community to promote healthy kids, families and communities.

Collaboration, Coordination and Care

Improving Care for Older Adults and Adults with Disabilities

As part of a statewide initiative, Compass Behavioral Health is working to support the health, safety, and independence of older adults and people with behavioral health needs. It does this by increasing collaboration and coordination among the agencies that serve this population, and by making sure that service providers are well trained. In 2018, the Compass Older Adult Health initiative trained 1,085 local care providers and community members. Trainings on such topics as Mental Health First Aid, Depression and Substance Use in Older Adults, Suicide Prevention, and Healthy Aging are helping to improve care for older adults and adults with disabilities.

Pain Matters

Taking Action to Address Opioid and Other Drug Abuse

As part of its efforts to expand access to mental health and substance use disorder prevention and treatment, SouthRiver convened community leaders, healthcare providers, law enforcement, emergency responders and community members to discuss solutions to stem the tide of drug abuse and related fatalities. In 2017, SouthRiver hosted Pain Matters—a community-wide event addressing the misuse of opioids, as well as illegal opioids like heroin. Over 25 community leaders received information on the prevention and treatment of opioid and other drug abuse, including training in the use of naloxone to prevent overdose deaths.

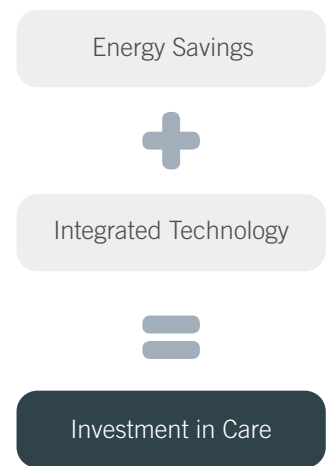
Improving Care Coordination
