




## Integrating Primary Care, Addiction Treatment & Behavioral Health

### Treatment Population by Division



## Opioid Treatment Program

### Restoring Hope & Recovery



Medication-assisted treatment combines prescribed medications—buprenorphine and methadone—with behavioral therapies to help people be successful in their treatment and achieve long-term recovery from alcohol, opioid and other drug dependence. We have worked hard to increase access to this life-saving treatment at our clinics in Coos and Douglas counties, and our work has paid off. In 2019, our Opioid Treatment Program in Coos County achieved CARF accreditation—joining our Roseburg program in demonstrating substantial conformance to the CARF standards of excellence. During the past year, 468 individuals received life-saving medication-assisted treatment at our clinics in Coos and Douglas counties—a 10% increase in patients served and a 24% increase in services provided over the prior year.

## Fresh Start

### Day Treatment & Housing Services

At Fresh Start Day Treatment in North Bend, clients receive the care they need to become stable in their treatment and recovery as a first step to a healthy and drug-free life. Fresh Start participants live in their own homes or participate in Fresh Start housing services while receiving treatment. In addition to personalized therapy, Certified Recovery Mentors assist participants with life skills training, job readiness, finances, and long-term plans for transportation and housing.

Over the past year we have taken a number of steps to meet the growing demand for day treatment services. As a result, 66 individuals were able to participate in Fresh Start Day Treatment—a 100% increase over the prior year.

*Prior to joining the Adapt program, I was homeless, void of any hope to live a normal life again, desperate and on the verge of suicide. Eight months ago, I was living on the street and destitute. Today I am living in comfortable housing, getting the counseling that I desperately needed, have a full-time job, a new car and money in the bank. All of this is due to Adapt and the amazing Fresh Start Program.*

## Youth Substance Use Treatment & Recovery

### A Foundation for Long-Term Recovery

Our outpatient and residential treatment programs are designed to help young people build a foundation for long-term recovery. Because substance use disorders don't exist in a vacuum, we emphasize a whole person approach to care—addressing co-occurring behavioral, emotional, and physical health problems that interfere with daily life. For nearly 50 years, our outpatient and residential treatment programs have provided young people with a supportive environment that reinforces healthy behaviors, relationships and lifestyles.



## COMPASS BEHAVIORAL HEALTH

### Meeting People Where They Are


Ensuring that people get the care they need no matter where they are – in clinics, schools, jails and community – is at the heart of our mission. With the transition of mental health services to Adapt in 2016, we have worked hard to build a robust Community Mental Health Program that offers greater access to care for those with the greatest needs. In 2019, Compass provided care to 3,716 individuals—a 28% increase since 2016.

System change to improve access to comprehensive care continues to be a high priority for us and for the individuals and families we serve. During the past year, we launched Open Access—also known as same-day scheduling—ensuring that new and existing clients can get the right care, at the right time. And, as part of our commitment to integrated care, our clients now have access to preventive, ongoing, and appropriate primary care as a core component of their basic services. These and other advances are allowing us to bring health, wellness and recovery within reach of more people.

## 24/7 Crisis Response

### Critical Access to Care When It's Needed Most

People living with serious mental health conditions often face a number of issues that increase the risk of crisis, including poverty, health problems, trauma, and co-occurring substance use. Compass provides 24-hour crisis response—in-person and telephone—that prioritizes public safety and the unique circumstances of the individual experiencing crisis. Our skilled Crisis Intervention Team works with law enforcement, health systems, social service providers, and others to provide solution-focused and recovery-oriented crisis intervention when it's needed most.

Our skilled mental health counselors co-deploy with the Roseburg Police Officers to safely and effectively assist people who experience crises in the community, and to connect them with the most appropriate level of care. The program has been recognized for helping to divert people away from jail to mental health care and other support services. In 2019, 796 people received crisis services, which includes mobile crisis intervention to 191 individuals.

## School-Based Mental Health

### Helping Students Become More Stable and Ready to Learn

We are honored to work with schools and families throughout Douglas County to identify and provide care for children with cognitive, behavioral or functional challenges. Because we aim to treat and stabilize young people in the least restrictive environment, we offer individual, group and family counseling year-round at schools and in students' homes. In 2019, skilled therapists provided counseling and supports to 665 students in 28 schools and one school-based health center.

Working in cooperation with the Douglas Education Service District, we increased psychiatric day treatment services—also known as Therapeutic Learning Classroom—for students in kindergarten through 8th grade with emotional or behavioral challenges. The goal of the program is to improve students' self-regulation, social and academic skills. This program is available to all Douglas County students in kindergarten through 8th grade in three regional locations—Roseburg, Myrtle Creek and Sutherlin. In 2019, 51 students participated in Therapeutic Learning Classroom.

# SOUTHRIVER COMMUNITY HEALTH CENTER

## Improving Health & Lives

In response to community need, SouthRiver has increased its capacity to provide the highest quality patient care—with new services and the growth of our talented clinical team. We made significant investments to achieve expansion and operational efficiencies to meet the increasing demand for affordable primary care and behavioral health services in our greater service area. Now with three fully-integrated clinic locations serving Winston, Roseburg and surrounding communities, we have seen a 27% increase in patients served over the prior year.

## Leading the Way

### Primary Care and Behavioral Health Integration

It's estimated that close to 70% of patients with a mental health disorder have at least one co-occurring medical condition. At SouthRiver, our primary care providers, behavioral health clinicians, and other care team members work together to coordinate care for patients with multiple healthcare needs.

In 2019, we met a major strategic goal to integrate primary care services into Adapt's outpatient behavioral health facility in Roseburg. The addition of the new site has improved access to primary care for adults with behavioral health disorders, thereby helping to improve health outcomes for individuals at greatest risk of poor health outcomes, including those with trauma histories and/or severe and persistent mental illness.

### Medication Assisted Treatment

#### Combining Behavioral Therapy & Medication

For some patients with opioid use disorders—including those related to prescription pain medications and heroin—medication-assisted treatment in combination with counseling and behavioral therapies can increase long-term recovery rates and reduce the risk of overdose. Over the past year, we expanded our clinical capacity to offer medication-assisted treatment to more patients. Nine SouthRiver providers have obtained a Drug Addiction Treatment Act waiver to treat opioid use disorder with medications specifically approved by the U.S. Food and Drug Administration. In 2019, 295 patients received medication-assisted treatment for opioid use disorder.




### Quality of Care Measures



We regularly monitor quality performance against national benchmarks. As a federally qualified health center, we are required to report gains made in meeting national benchmarks for several quality of care measures. Our clinical team reviews quality of care measures and creates performance improvement plans to enhance patient care and improve health outcomes. In 2019, SouthRiver met or exceeded targets on a number of measures.

# ENGAGING PEOPLE AND COMMUNITIES

## Working Together to Improve Health

Many of the services we provide rely on the strength of community to help individuals and families overcome physical and behavioral health challenges. When committed individuals and organizations come together to support our mission, they make a powerful difference in the health of our community.

## Supportive Housing Is Healthcare For People & Families in Recovery

Adapt operates Supportive Housing for non-parenting adults and for adults with children in Douglas, Coos and Josephine counties. People in recovery from substance use disorders benefit from a supportive environment while they are in treatment and learning to live on their own—moving on to independent housing after they have become comfortable in their sobriety. Supportive housing is not only a highly effective solution to homelessness for vulnerable individuals and families, but also one that is making it possible for people to live, recover, and thrive in the community.

## Healthcare for the Homeless Bridging the Gap to Care

Integrated care is essential to meet the complex needs of people experiencing homelessness. In the clinic, SouthRiver's medical and behavioral health providers, outreach workers, case managers, eligibility workers, peer mentors, and others work together to bridge the gap between healthcare and people experiencing homelessness. In the community, we are working with social support organizations, landlords and housing developers, the faith community, city and state officials, advocates for the homeless, and others to increase opportunities for people experiencing homelessness to receive the care they need—regardless of ability to pay.

## Older Adult Behavioral Health Improving Care for Older Adults and Adults with Disabilities

Compass Behavioral Health Older Adult Health initiative is working to support the health, safety, and independence of older adults and adults with disabilities. In 2019, 1,107 community members and local care providers participated in over 60 trainings on a variety of topics, including safe medication use, communicating effectively with healthcare providers, suicide prevention, depression and substance use, and strategies for healthy living. In partnership with Douglas County Senior Services, the 6-week Wellness Initiative for Senior Education program was delivered at senior centers throughout Douglas County.

## Suicide Prevention

### Giving People the Tools to Respond

Because mental health and substance use disorders are two of the most significant suicide risk factors, we are working to save lives by equipping people with the knowledge and skills needed to respond to those at risk. This year, our Prevention and Older Adult Behavioral Health staff trained over 300 community members in Douglas and Coos counties to identify the risks of suicide and how to respond to someone in crisis. When more people are equipped with the tools they need to respond, more people can get the help they need.

## Peer-Delivered Services

### The Power of Lived Experience

Peer Delivered Services are part of integrated team-based care for adults with mental health and/or substance use disorders. Certified Recovery Mentors and Peer Support Specialists combine the power of their lived experience with training to support individuals who are navigating their own road to recovery.

A total of 16 Peers in Douglas, Josephine and Coos counties develop meaningful and trusting relationships with our clients and serve as connectors to essential recovery support services, such as housing, employment, transportation, child and parenting resources, and supplemental benefits. Skilled Peers work in close cooperation with coordinated care organizations, hospitals, social service agencies, faith communities, and the justice system to help our patients be successful in their treatment, communities, and lives.




# COMMITMENT TO EXCELLENCE






## Employee Training & Development

In 2019, and with rigorous credentialing requirements for behavioral health treatment providers, 115 Adapt, Compass and SouthRiver employees were newly certified or recertified as Qualified Mental Health Professionals, Qualified Mental Health Associates, and Clinical Social Work Associates. By creating opportunities for professional growth, we are building a more robust workforce that pays off in increased access to care in the communities we serve.




